"Prohibition":-

No person shall, except with the prior approval of the Board, print, publish, sell or prescribe in an institution any textbook or supplementary material.

An application for approval to print, publish, sell or prescribe in an institution a textbook or supplementary material shall be made in such manner and form and on the payment of such fee as may be prescribed. The Board may direct any person to amend, delete or withdraw any portion or the whole of curriculum, textbook or supplementary material. (2) (3)

The Board may direct any person to amend, delete or withdraw any portion of the whole of cuthants texthook or supplementary material.

The Board may prohibit any person or agency from producing printing publishing, selling or using in an institution any textbook or supplementary material or any part of it.

The Board shall not approve the printing publication, selling or prescribing in an institution of any textbook or supplementary material which is or is likely to be destrimental for examination or assessment purposes, or which contains anything repugnant to the injunctions of Islam, or contrary to the integrity, defence or security of Pakistan or any part of Fakistan, public order or morality.

If the Board issues a direction or prohibition under subsections (3) or (4) to a person or an agency, such person or agency shall, within the time specified by the Board, submit an implementation report to the Board.
